# Percolation as a gauge theory I: general features and properties

We review the formulation of the random percolation model interpreted as a fully consistent confining gauge theory, providing both theoretical motivations and the numerical results collected throughout the years. We show that, with a clever definition of the usual lattice pure gauge observables, the model well fits into the center vortex picture of confinement as well as agreeing with the effective string predictions. A particular emphasis is devoted to finite-temperature behaviour of Polyakov loop correlators, whose leading and next-to-leading quantum corrections are expected to be more-than-universal, in the sense that they are oblivious to the particular choice of the gauge group, leading to a very general prediction in the temperature-scaling of the string tension.

#### Lattice pure gauge theories

A pure gauge theory on the lattice usually:

- is constructed starting from the expectation values of closed loops;
- is probed by means of the interquark potential between static external sources;
- ullet exhibits a confinement/deconfinement phase transition, where  $\sigma \to 0$ ;
- ullet admits a finite-temperature reformulation with a deconfinement point  $T=T_c$ .

By choosing an action functional S and a gauge group G, the gluodynamics details are specified (conservation laws, fluxes sum rules, etc. . . ).

# A general mechanism

The lattice allows for models with discrete gauge group (simpler to treat); moreover, we can switch to (2+1)-dimensional systems for simplicity and (in most cases) still observe confinement phenomenology.

Although each G determines its own universality class, it turns out that the confinement-related quantities usually vary very weakly. In particular, we consider the universal ratio

$$\frac{T_{cr}}{\sqrt{\sigma}}$$

In order to better highlight the simple basic mechanism common to confining theories, we will proceed toward a dramatic simplification of the model.

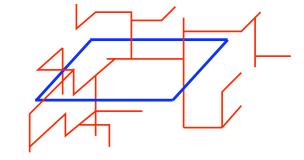
#### Center vortices and confinement

In a given gauge configuration, there is a network of **center vortices**, extended objects related to nontrivial gauge transformations; a vortex gives a multiplicative contribution to W(R,T) if it pierces the loop, and there is confinement if the vortex graph is structured in such a way that W(R,T) decays with an area law (the vortices are able to disorder the gauge field).

Supporting facts:

- experimental observation of center dominance;
- $\bullet$  sensitivity of finite-temperature observables to the center of  $\mathbb G$  .

Vortices must be weakly correlated.



When G = SU(N), only N-uplets of vortices can join together (flux conservation): dependence on gauge group!

#### Flux tubes and confinement

The vacuum acts on the (chromo-)magnetic field as a **dual superconductor**, keeping all the flux between the sources squeezed in a string-like tube whose energy is proportional to its length  $\Rightarrow$  linear growth of V(R).

A strong coupling expansion of  $\langle W \rangle$  can be made in terms of string worldsheet surfaces (bounded by the loop contour); this expansion fails for too weak couplings.

Indeed, since the physics takes place in the so-called rough phase (the string fluctuates quantistically on any length scale), there are many all-new predictions that can be tested on the lattice.



## The flux tube as a vibrating string

In the large interquark separation limit  $(R \to \infty)$ , the rough flux tube is treated as a massless bosonic string, with Nambu-Goto action  $\propto -(\sigma \cdot \text{Area})$ . The expansion parameter is indeed  $(\sigma \cdot \text{Area})^{-1} \ll 1$ .

This effective theory is consistent only for D=26; however, by a slight modification in the action, another effective theory was proposed [Polchinski, Strominger, 1991], which mimics the Nambu-Goto formulation but is valid in any dimensionality  $D\geq 3$ . Open-closed string duality arguments in D=3, along with some calculations for any D, suggest the first two terms of the effective theory to be universal.

Note: the "class of actions" of the Nambu-Goto family unambiguously determines the functional form of a loop up to the NLO order: were it possible to prove the presence of a further term, an actual realisation of an effective string theory would have been observed (more on effective strings later!).

#### Toward percolation theory

Let's start with the 3D  $\mathbb{Z}_2$  theory, the simplest nontrivial gauge model.

- Kramers-Wannier duality transformation  $\Rightarrow$  3D Ising model (one-to-one mapping between observables and couplings in the two models).
- Fortuin-Kasteleyn reformulation for the Ising model, in terms of random clusters of aligned sites.
- In this context, W(R,T) is zero whenever a magnetised cluster is linked to the loop, since this fact is incompatible with the  $\mathbb{Z}_2$  unit flux running on the loop contour. To be precise, a generic even winding number is allowed (following  $\mathbb{Z}_2$  algebra).

## Random percolation as a gauge theory

Naive, simple extension of the above recipe, in which only the topological properties are relevant:

- The lattice links are independently set to on or off according to probabilities p and 1-p: a random cloud of connected on clusters is formed.
- This is a critical system: there exist a value  $p_{cr}$  at which an infinite connected network appears ( $percolation\ threshold,\ second\ order\ critical\ point$ ).
- Formally, this model has  $\mathbb{G} \equiv \{e\}$  and  $Z \equiv 1$ .
- We need observables sensitive only to the configuration topology (no *dangling* ends for instance), as some sort of gauge invariance.

#### Wilson loops and confinement in random percolation

One is led to define the Wilson loop value  $W(\mathcal{C})$  in a given configuration  $\mathcal{C}$  as:

W = 1 if no clusters are linked to the loop; W = 0 otherwise.

The definition is completely invariant under any transformation that does not alter the *loop* structure of the configuration, as required.

 $p < p_{cr} \Rightarrow$  finite-size clusters give the perimeter law  $\Rightarrow$  deconfinement  $p > p_{cr} \Rightarrow$  the infinite cluster can pierce W in any point  $\Rightarrow$  confinement

This definition can be applied to Polyakov-Polyakov correlator functions in a straightforward manner.

## Finite-temperature deconfinement in random percolation

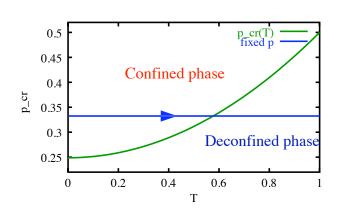
At finite temperature T, the system is a 2D infinite slice with thickness  $\propto 1/T$ : the threshold probability  $p_{cr}(T)$  for the infinite cluster to appear is now a function of T and follows two-dimensional scaling laws.

Since  $p_{cr}(T)$  is an increasing function of T, by keeping a fixed probability  $p_{cr}(0) and heating up the system, the infinite cluster at some point <math>T_{cr}$  vanishes away, leaving finite pieces that no longer give the area law to the loop behaviour: this is precisely a finite temperature deconfinement transition.

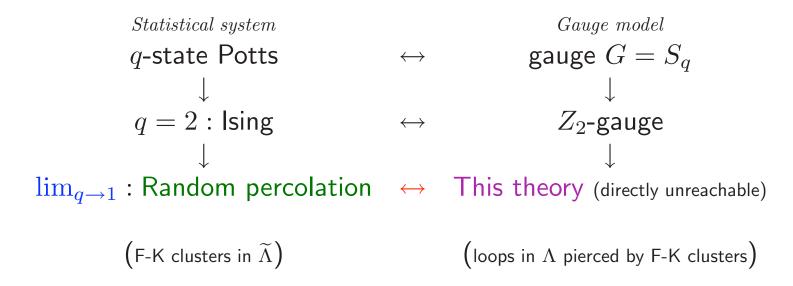
The amplitude ratio  $T_{cr}/\sqrt{\sigma}$  is well defined, with scaling laws:

$$\sigma(p) = S(p - p_{cr})^{2\nu};$$

$$T = \tau_0(p_{cr}(T) - p_{cr}^{3D})^{\nu}.$$



#### The gauge model is dual to the percolative system



The percolating graph stands for the F-K cluster structure; nevertheless, since any conservation law is dropped, it can be thought of as the center vortex network (which carries the "trivial group" charge).

Numerical advantage: with Z=1 (no update processes), high statistics are attainable.

Conceptual advantage: the core of confinement can be observed without group-specific artifacts.

#### **Established numerical results**

A consistent picture has emerged, which gives this theory the full status of a well-behaved gauge theory:

- Zero-temperature deconfinement transition, with well-defined string tension scaling.
- Glueball spectrum comparable to that of other gauge theories.
- Finite-temperature transition well studied via Polyakov-Polyakov correlators.
- ullet Universality of the adimensional ratio  $T_c/\sqrt{\sigma}\simeq 1.5$  .

## A quest for a string theory

Wilson and Polyakov loops clearly show the effects of an underlying fluctuating string correction, even though the model does not explicitly include such objects.

Example: For square Wilson loop at zero temperature, using the LO function  $W(R,R) \propto R^{1/4} \exp(-\sigma R^2 - 2cR)$ , instead of the "classical" form  $W(R,R) \propto \exp(-\sigma R^2 - 2cR)$ , leads to much better agreement with the numerical data and allows a fine determination of the string tension.

These corrections (to the "classical" area+perimeter law) are found to match, at the NLO, those from the Nambu-Goto predictions (see the talk by  $P.\ Giudice$ ).

With the high statistics available, one can look for extremely fine string effects in loops' functional form. This is particularly true for the finite-temperature Polyakov-Polyakov correlation function . . .

## Predictions from the effective string theory

The Polyakov-Polyakov correlation function has the form of a "classical" term, with a multiplicative contribution coming from the rough string fluctuations:

$$\langle P(0)P^{\dagger}(R)\rangle_{T=1/L} \propto [exp(-\sigma RL - cL)] \cdot Z_q$$
.

With an order-by-order  $\zeta$ -function regularisation procedure, from the N-G action

$$S_{NG} = \sigma \int_0^L d\tau \int_0^R dr \sqrt{g} ,$$

it is possible to express the correction  $Z_q$  as an expansion (valid in the infrared limit) in the small quantity  $(\sigma RL)^{-1}$ .

# NLO expansion for the Polyakov-Polyakov correlator

Consider a couple of Polyakov loops at a distance R in a system of temperature T=1/L (in lattice spacings). At the Next-to-leading order in  $(\sigma RL)^{-1}$  the functional form obtained is:

$$< P(0)P^{\dagger}(R)> = \frac{e^{-cL - \sigma RL - \frac{(D-2)\pi^2 L[2E_4(\tau) - E_2^2(\tau)]}{1152\sigma R^3} + \mathcal{O}(1/R^5)}}{\eta(\tau)^{D-2}}$$

$$\eta(\tau) \equiv q^{\frac{1}{24}} \prod_{n=1}^{\infty} (1-q^n) \qquad \text{Dedekind eta function} \quad \left(\tau = \frac{iL}{2R} \; ; \quad q(\tau) = e^{2\pi i \tau} = e^{-\pi \frac{L}{R}}\right)$$

$$E_2(\tau) \equiv 1 - 24 \sum_{n=1}^{\infty} \sigma_1(n) q^n$$
 second Eistenstein function

$$E_4( au) \equiv 1 + 240 \sum_{n=1}^{\infty} \sigma_3(n) q^n$$
 fourth Eistenstein function

#### String tension at finite temperature

The LO and NLO terms are *universal* in a much broader sense than the usual statistical meaning: they are expected from **any** pure gauge confining theory (for a given dimensionality) which flows to a massless bosonic effective string in the infrared.

By making use of the properties of the Eisenstein and Dedekind functions under modular transformation, the equation

$$\langle P(0)P^{\dagger}(R) \rangle = \frac{e^{-cL - \sigma RL - \frac{(D-2)\pi^2 L[2E_4(\tau) - E_2^2(\tau)]}{1152\sigma R^3} + \mathcal{O}(1/R^5)}}{\eta(\tau)^{D-2}} ,$$

can be recast in terms of temperature-dependence of the string tension as:

$$\sigma(L) = \sigma_0 - \frac{\pi}{6L^2} - \frac{\pi^2}{72\sigma_0 L^4} \quad , \quad R \to \infty \quad (NLO) \; ,$$

where  $\sigma_0$  stands for the zero-temperature string tension.

#### **Conclusions**

Percolation is a well-defined gauge theory, notwithstanding having been constructed in purely topological terms; moreover, it can somewhat grab the common features of all confining theories and, at the same time, get rid of group-dependent dynamics details.

Having no dynamics at all, this theory is a gold mine in computational terms (no thermalisation, no critical slowing down, no update process) and allows to reach impressive statistics and volumes.

The key feature is the clear appearance of effects which can be ascribed to an effective confining string. These effects match the N-G prediction up to the universality threshold, showing that random percolation encodes an actual realisation of a (necessarily finite and predictive) string model, whose details will be contained in the next-to-NLO terms.
